**Important Notes :** 1- The school submitted in self declaration that they have already applied for recognition certificate for classes 1-8 in 2019. The school is required to make efforts to obtain recognition certificate soon. Above condition has already been conveyed to the school earlier vide grant letter in regard of application no. SS-00735-2122 where a 1 year time was given to the school. It must be noted that further extension of Provisional Affiliation and Up-gradation will not be considered without valid Recognition Certificate.
