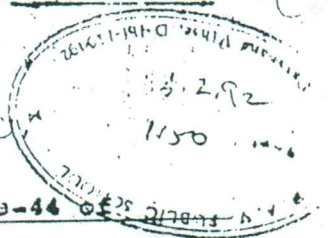

Subject:- Issue of essentiality certificate under Rule-44 of Delhi School Education Act & Rules, 1973.

Sir,

With reference to your application on the subject cited above, I am directed to convey the permission of the appropriate authority to your Society to establish a new school from 1st to VIII th (without aid) in Zone No. IX, Distt. East, place Mauwan Vihar, Delhi-92 subject to the following conditions:-

1. That the provisions of Delhi School Education Act, 1973 and Rules framed thereunder shall be observed by the Society.
2. That the Management of the school will get the Scheme of Management approved from the Department immediately.
3. That the Management of the school will not ask for grant-in-aid from the department.
4. That the school will not run for the profit of any individual, Association or group of persons.
5. That the Management of the school will apply for the grant of recognition under D.S.E.A.&R., 73 and recognition will not be granted unless statutory provisions of Section 4(1)(a) to (f) read with Rules 50 & 51 are fulfilled.
6. That the school shall be run under the control of DAV College Trust & Management Society, Delhi and suitable funds will be laid on the land allotted to the Society as per the specification of the Deptt. within a period of THREE YEARS.
7. That the management of the school will obtain land from D.D.A. in the name of the Society through Dte. of Education, Delhi and shall construct a school building thereon as per the specifications of the department.

That adequate and sufficient accommodation of 12 sq.ft. per student shall be provided for class room. The normal size of class room will be 33' x 20'. No other activities other than education shall be run in the school premises.

If recognition for the school is not sought after fulfilling all the above conditions within a period of THREE YEARS, this permission to run a new school shall be treated as cancelled.
