Eligibility & Other Information:

- 1) The bidders should be an Indian Firm engaged in civil work and Registered as per existing norms from Government Department.
- They should have minimum three years of experience in the field and worked with Govt. Depts/PSUs/MNCs/etc.
- 3) They should not have been blacklisted by the Departments/Ministries of the Govt. of India Declaration to this effect is to be submitted.
- 4) For bidding, the firms are required to submit the following self-attested and duly rubber stamped (on each page) photocopies of the following documents relating to their printing press/firm:
 - a) Registration Certificate as per existing norms from Government Department;

b) Copy of GST Registration Certificates;

c) Copy of latest GST return;

d) Copy of PAN Card,

- e) Declaration regarding blacklisting

- 8) The work must be completed withing 02 month from the date of allotment of the said work.

10)In the event of failure on the part of work by the Bidder/Firm, the rest work may get completed from another firm and the previously engaged bidder/firm will have to

reimburse the extra expenditure incurred thereafter.

- 11) Payment against Bill/Invoice shall be released only after completion of the work to the satisfaction of the architect & competent committee. No interest will be payable on the delayed payments. Payment will be made directly to the firm through Multi-city cheque only. No request for other mode of payment will be entertained. Work is divided in Two parts and payment of each part will be made separately on completion of work. No advance payment will be made in any case. However, part payment can be done on satisfaction of Architect.
- 12) The Tenderer will be bound by the details furnished by him/her while submitting the tender or at subsequent stage. In case, any of such documents furnished by him/her found to be fictitious at any stage, it would be deemed to be a breach of terms of contract making him/her liable for legal action besides termination of the contract.
